West Palm Beach, for appellee. OWEN, Judge. The defendant was indicted and tried for murder in the  
first degree and a jury found him guilty of manslaughter in the first degree with recommendation of  
life imprisonment. The defendant urges two points for reversal, neither of which is meritorious. The  
defendant's first point is that the trial judge erred in permitting the State to cross-examine the  
defendant concerning his prior arrest. We hold that this is not reversible error. An objection was  
raised to the admission of the defendant's previous arrest but the basis for the objection was not  
pursued at trial. Consequently this point has not been preserved for consideration on appeal. State v.  
Otero, Fla. 1967, 195 So.2d 213; State v. Turnquest, Fla. 1971, 246 So.2d 515. The defendant's  
second point on appeal is that he was denied his constitutional right to a fair trial by reason of a  
conflict of interest arising from the position taken by the public defender representing the defendant.  
During the course of the trial it became apparent that the State's witness, Larry King, the deceased's  
uncle, had in fact committed an assault on the defendant when the two were at a public drinking  
establishment together six months before the \*168 homicide. The defense filed a motion for a  
continuance to secure the presence of an independent psychiatrist to determine King's mental  
capacity to testify. At the time the continuance was denied, the defendant's public defender  
explained his motion on the ground that the State "has produced Mr. King as a witness in opposition  
to the motion for a continuance...
